

OHIP Billing: Vaccination Schedules

Quick Reference Guide

With vaccines ranging from flu season shots to those given during childhood and adulthood, it can be challenging to remember which vaccine codes correspond to each vaccine and the appropriate timing. This short guide offers a clear overview of all vaccines a patient receives throughout their life.

Sole Reason for Immunizations

Physicians can bill G700 in addition to immunization codes when seeing a patient solely for immunizations.

First Year Vaccines

Vaccines that should be given to an infant in their first year of life are the following:

2 and 4 months

Second Year Vaccines

Vaccines that should be given to a patient in their second year of life are the following:

Vaccines that should be given to a school-aged child are the following:

Between 4 and 6 years

Vaccines for Adults

Vaccines that should be given to adults throughout their life are the following:

G590	Influenza	\$5.40
G846	Pneumococcal Conjugate	\$5.40
G847	Diphtheria, Tetanus, acellular Pertussis (Tdap) – adult	\$5.40

Billing and Payment Rules:

- Tetanus and diphtheria (Td) are administered every 10 years
- The shingles vaccine is 2-dose series between age 65 to 70
- The influenza vaccine is recommended every fall
- Tdap should be administered once in adulthood and once in every pregnancy

Influenza and COVID-19 Vaccine for All

FHO/FHN physicians can bill Q590 in addition to G590 when seeing a patient solely for Influenza immunizations.

Fee Code	Fee Description	Value
Q590	Basic Flu Shot premium (FHO/FHN only, out-of-basket)	\$5.10
G590	Influenza (every fall for everyone 6 months and older)	\$5.65

FHO/FHN physicians can bill Q593 in addition to G593 when seeing a patient solely for COVID-19 immunizations.

Fee Code	Fee Description	Value
Q593	COVID-19 Sole Visit premium (FHO/FHN only, out-of-basket)	\$5.60
G593	COVID-19 (for everyone 6 months of age and older)	\$13.00
